The organization conducts ongoing reporting projects in areas such as the environment, criminal justice, money and politics and government oversight. The reporting is then produced into multiple media formats and is published and broadcast on the organization's website as well as in newspapers, magazines, and books, and on radio, television and other news websites. The organization then uses social media, organizational collaborations, in-person events, and print and web materials to distribute its reporting to communities most impacted by the information it uncovers, and to engage the public in seeking solutions to the problems on which it reports.

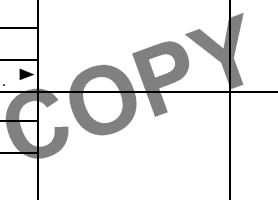

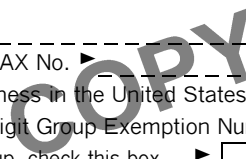
